## Tax Incentives - Up to 50%

Navarra was the first region in Spain to promote audiovisual production in Spain through tax incentives. Today, the region has developed the most **legally secure system of tax credits** for investors and producers in Spain. It also has a strong group of mature investors, who know and trust the tax tool and are waiting for the arrival of new projects in which to invest.

## Projects & Business Support

Navarra offers diverse services and infrastructures to provide fully integrated support and contacts for both **audiovisual productions** and the **establishment of new companies** in the region. The **proximity and speed of response of the public administration** greatly facilitates the management of audiovisual projects in our region.

## Exceptional locations & Infrastructures

Navarra enjoys a **wide variety of locations** that position the region as a unique destination for filming. Our region boasts deserts, steep valleys, ancient oak groves, medieval villages, cities, industrial infrastructures, urban modern architecture, palaces, all **within 10,000 Km2** and connected by an excellent network of infrastructures. In Navarra there are also several film sets and auxiliary Infrastructures.

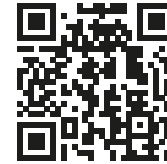
## Talent, AI and R&D

Navarra has a **highly qualified professional network** capable of covering any professional profile in audiovisual production. Plus, Navarra boasts financial resources to organize tailored training actions to the specific needs of a project or company and has a **strong R&D system that facilitate the financing of technological projects** related to the audiovisual industry (2D and 3D animation projects, video games, VFX, XR, etc).

## AUDIOVISUAL TAX DEDUCTION



- **Special:** 50% in the first three million of the deduction base.
- **General:** 45% of the deduction base.
- **Special deduction:** Animation productions; V.O. Basque language; Led by women; Documentaries; Novel direction, Short films.
- **Three areas of coverage:**
  1. Producers or co-producers of Spanish productions, motion pictures and other audiovisual productions, feature films and short films.
  2. Services in charge of the execution of foreign productions of cinematographic films or audiovisual works.
  3. Taxpayers of Corporate Income Tax or Non-Resident Income Tax who participate in the financing of Spanish productions of cinematographic films and other audiovisual works of fiction, animation or documentary.

## GENERAZINEMA & INDUSTRY GRANTS



The Government of Navarra's Directorate-General for Culture calls for applications for the **Generazinema grants every year:** five categories of grants, funded through an open and competitive process, which aim to promote projects based in Navarra and to cover the **entire audiovisual value chain**. The funding subsidises the development, production and promotion phases of audiovisual productions, as well as the organisation of film festivals and programming in cinemas.

Additionally, Navarra has an extensive catalogue of grants **to facilitate the establishment of audiovisual companies:** aid for investment, personnel hiring, R&D&I projects, technology-based companies, etc.
